## Teacher Professional Development Illinois Cpdus

In order to renew Illinois' standard Professional Educator License (PEL), the educator must have attained a minimum of 120 professional development hours. The Illinois State Board of Education maintains a list of approved providers of professional development, and it is required that these providers equate one clock hour of attendance with one professional development hour.
